





CSX apps looks to help hazmat train accident first responders

To help emergency personnel responding to a railroad accident, CSX is launching a mobile app that sends real-time data to first responders about what the train is carrying.

The app, called CSX Operation Respond, provides emergency response teams mobile access to crucial data such as what hazardous materials might be on board a train that's been involved in an accident, the company said.

The app syncs with the company's real-time database, providing responders with everything they might need to know should an accident occur. All they need is the marking number on the side of the car, spokeswoman Melanie Cost said in an interview with the Business Journal.

"It's specifically designed for first responders who need it for rail-related accident response," Cost said.

Several emergency personnel are testing the app, which is yet to make its mainstream debut. "Some first responders are testing it now, and we're getting feedback to ensure it's calibrated to their needs," Cost said.

The app is part of the company's ongoing emphasis on public safety, said Kristin Seay, also a spokeswoman for the company. Currently, she said, CSX spends \$2 billion a year to improve safety and reliability of its network.

Railroads have come under scrutiny for the transportation of hazardous material. Politicians are concerned about the possibility for accident when materials like crude oil are on board. Recently, city council members in Chicago — a rail transportation hub — have called for stricter regulations from the federal government on tanker trains, reported sister paper Chicago Business Journal.

"We strive to work closely with first responders and local authorities," she said, "to help them be as prepared as possible in the event of a rail incident."

CSX wanted to provide an app, Seay said, so there could be more mobile access to data. With the app, access isn't tethered to a desktop computer: it can be viewed from a laptop or mobile device.

"I would say it's one more tool that first responders would have to be better prepared in the event of an incident," she said.
