

# 2. Approval of Minutes

A motion to approve the minutes of the February 4, 2015 District 2 Local Emergency Planning Committee meeting was made by Eve Rainey and seconded by Chief Tom Quillin. The vote was unanimous.

Chairman Peters announced that the presentation under 'Other Business' would be moved to accommodate Leon County Schools and their colleagues. Manny Joanos of Leon County Schools provided an informative presentation on the compressed natural gas school buses used within the county. Some of the highlights included:

- Started using 8 CNG buses in Leon County in 2008-09
- Quieter engines, less fumes and cheaper fuel
- Expanding to 94 buses in August 2015 (half of total fleet)
- No safety issues to date
- Watched a 10-minutes YouTube video on CNG Safety
- Fueling center in on Connor Blvd
- Safety measures have been implemented at fueling facilities (lighting, lightning arrestors, etc.)
- Should result in 25% increase in the expected life of the buses

Mr. Joanos fielded several questions from the membership and concluded the presentation. Chairman Peters thanked Mr. Joanos, Leon County Schools and Cummins Power South for their time and invited them to stay for the remainder of the meeting.

  - Code Enforcement and law enforcement officials are virtually unaware of the program
  - Would greatly appreciate the LEPCs assistance in getting the word out on the Call Before You Dig program (Ch. 556 F.S.)

Supplemental Environmental Project (SEP) Database Presentation by Richard Butgereit

- Database is up and running, but not available for full use (not officially released yet)
- Would still like to see :
  - ability to upload attachments (e.g., invoices, specs, etc.) as well as review by LEPC and approval by EPA
  - Pre-populate LEPCs, fire stations
  - o Sort by status
  - Projects ad
- <u>www.floridadisaster.org/SEP</u>
- When you log into SharePoint, you can view the projects
- We have been asked to hold off on outreach until the enhancements are completed
- DEM estimates there are 3-5 facilities per year in Florida that are fined by the EPA
- If SEP is selected in lieu of fine, 75% of fine can be applied to project
  - 25% will go to General Treasury

HA Work Group Update by Dwayne Mundy

- RPCs not handling HA Program management in 2015-16 due to the denial of budget authority by the Governor's Office
- Critical facility inventories are available through SharePoint (same as GATOR)
- Can be downloaded into ARC GIS or the new Marplot
- Progress is being made towards getting the HAs into GATOR

FY 2015-16 HMEP Grant Review by Paul Wotherspoon

- State funding has been reduced again this year
- District 2 received \$22,000 for planning and \$38,447 for training in 2014-15
- Amounts for 2015-16 are unknown at this time

• Paul has application available upon request

FY 2015-16 Draft HA Contracts distributed for review

- Contracts appear to be the same as last year
- \$110 penalty per facility with mistakes after first review
- Asked be DEM to forward out facility lists to counties that perform their HAs

  - 1. 11,100 have registered, with about 10% that have not

  - Next Region 2 RDSTF meeting is tentatively scheduled for June 5<sup>th</sup>

# EPA Inspections Reveal Clean Air Act Violations at Wilbur-Ellis Company Facilities in White Cloud, Troy and Silver Lake, Kan.

(Lenexa, Kan., July 16, 2015) – In a settlement agreement with EPA Region 7 filed today, Wilbur–Ellis Company has agreed to pay a \$67,404 civil penalty to settle alleged violations of the Clean Air Act at its fertilizer facilities in White Cloud, Troy, and Silver Lake, Kan. The company is also required to spend an additional \$113,121 on emergency response equipment to complete a Supplemental Environmental Project, benefitting the Sedgwick Fire Department and Doniphan County.

EPA inspections revealed the company exceeded the threshold quantity of anhydrous ammonia in processes at each of the three facilities. This requires each facility to file a Risk Management Plan with EPA and implement a risk management program. The inspections also noted violations of the Clean Air Act's Chemical Accident Prevention regulations at each facility.

Anhydrous ammonia is used in fertilizers, and can cause rapid dehydration and severe burns if inhaled. Short-term exposure at high concentrations can cause death. The threshold quantity of anhydrous ammonia in a process is 10,000 pounds. Facilities holding more than 10,000 pounds of anhydrous ammonia in a process are required to comply with EPA's Risk Management Program regulations.

The regulations seek to prevent accidental releases of extremely hazardous substances and reduce the impact of releases that do occur. The Risk Management Plan is available to help local fire, police, and emergency response personnel prepare for and respond to chemical emergencies at the facilities.

"Companies have a responsibility to their employees, and the surrounding communities, to ensure they are using the best safety practices, and adhering to all regulations, when working with potentially dangerous chemicals," said EPA Region 7 Acting Administrator Mark Hague. "The Chemical Accident Prevention regulations exist to help ensure our communities are healthy, and that companies are doing all they can to work safely."

In addition to the \$67,404 cash penalty, Wilbur-Ellis will provide \$113,121 worth of emergency response equipment to the Sedgwick Fire Department and Doniphan County through performance of a Supplemental Environmental Project. A SEP is intended to be a project that produces environmental or public health and safety benefits, earning partial credit by EPA to offset the cost of the penalty.

"A Supplemental Environmental Project is a great tool to provide tangible benefits to the communities near these companies, while also holding the companies accountable to applicable environmental laws and regulations," said Hague.

By agreeing to the settlement, Wilbur-Ellis Company has certified that it is in compliance with the Clean Air Act and all of its requirements.

SUBJECT: Issuance of the 2015 Update to the 1998 U.S. Environmental Protection Agency Supplemental Environmental Projects Policy

I am pleased to issue the 2015 Update to the EPA Supplemental Environmental Projects Policy (Update or 2015 Update), which reflects and incorporates by reference all of the guidance and implementation decisions made about Supplemental Environmental Projects (SEPs) since the issuance of EPA's SEP Policy in 1998. This Update supersedes the 1998 Policy, and is effective immediately.

Consolidating the wealth of existing SEP guidance is intended to encourage use of the Policy by helping facilitate and streamline the inclusion of SEPs in civil enforcement settlements whenever appropriate. The 2015 Update is also intended to underscore the Agency's continuing strong support for SEPs, which can be powerful tools to secure significant environmental and public health benefits beyond those achieved by compliance, and to help address the needs of communities impacted by violations of environmental laws.

The Update covers when it is appropriate to include a SEP in an enforcement settlement, how to evaluate proposed SEPs, and the information and certifications that must be included in settlement documents. It reflects all SEP-related guidance documents issued by OECA over the past seventeen years, as well as the policy and implementation decisions made during two national meetings organized by OECA's Principal Deputy Assistant Administrator.<sup>1</sup> It also provides clarifying language on points of longstanding implementation practice and technical corrections. The 2015 Update highlights some notable Agency priorities, including Children's Health, Environmental Justice, Innovative Technology and Climate Change. In addition, for ease of use and clarity certain sections of the Update have been edited and reordered, and the Policy now includes a topical Table of Contents.

The Update reflects the collaborative efforts of our National SEP Work Group, our Regional Counsel and Enforcement staff, our Office of General Counsel, the Department of Justice, and OECA staff from the Office of Civil Enforcement, the Federal Facilities Enforcement Office, the Office of Environmental Justice and the Office of Site Remediation Enforcement, as well as input from several EPA program offices. I appreciate their collective efforts and thank them for their willingness to help facilitate this Update.

My hope is that this Update will enable case teams to more efficiently and effectively include SEPs in settlement of civil enforcement cases, and I continue to actively encourage all enforcement practitioners to consider SEPs wherever they may be appropriate.
