CSX Operation Rail Respond Presentation by John McFall

- As a CSX Rail Respond user, you now have the ability to view a recommended commodityspecific Isolation Zone while in the Demo mode
- The Isolation Zone button will be available for rail cars carrying hazardous materials.
- This feature allows you to think through potential plans and resource needs associated with key commodities you may encounter.
- Sam MacDonnell reported that he never received a certificate of Operation Rail Respond access after attending training in Marianna
  - Staff noted that he would notify his CSX contacts for an update

LPG Inspection by Betty Merritt, FDACS

- 12 LPG inspectors in the state of Florida
- All inspectors have experience in the industry

SEP Presentation by Terri Platt, EPA

- Has to be environmentally beneficial (see EPA Missions)
- Has to relate to underlying issue
- Has to come out of a settlement (not a court trial)
- 80% of SEPs are EPP projects even though it does not cover 100% of the fine
  - Likely due to better PR for the company
- Rodney Andreasen asked what efforts could be made to provide more training to the small WTP/WWTPs
  - Staff noted the Florid Rural Water Association may potentially be a resource
  - Staff also noted that he would provide that HazMat FOG to Mr. Andreasen

Renaming of the LEPCs

Good morning all,

We have received our estimated allocation for the next HMEP grant cycle. We have received a reduction of \$156,000 in allocation with an anticipated allocation of \$631,000 per year. The reduction is predicated on a new formula, the first since 1996, which includes population, highway/railway miles, and transportation related hazardous materials incidents. I have asked USDOT to provide me with the figures used to calculate our allocation. I have also asked they reconsider such a sizeable reduction during a single grant cycle. You can do the math – avg \$15,000 reduction per LEPC – actual will still be formula calculated.

I will keep you posted on the results of my requests to DOT.

Good morning,

I am forwarding the calculations for the 2016-19 HMEP grant. It appears that since Florida has done such a good job of reducing transportation related hazardous materials incidents, and mitigating those that do occur, our "need" for related training funds is reduced. The old formula included number of fixed facilities, highway and rail miles, population, and commodities transported. A consulting firm was hired by US DOT to determine the most accurate method of determining "risk" for future HMEP allocations. The firm came up with 4 options, most included similar factors. The formula below was the one selected.

I will continue to present a factual case to US DOT for reconsideration of such a drastic reduction year over year. Again, I will keep you all up to date on any new information I receive.

#### 8-hour OSHA HazMat Technician Level Refresher Course

The Apalachee Local Emergency Planning Committee (LEPC) is sponsoring a one-day (8-hour) **HAZWOPER Refresher Training** for public safety responders, public works, public health, and utilities employees. This course provides OSHA Technician Level trained personnel first-on-the-scene with refresher information needed to recognize, evaluate, and control an incident involving the release or potential release of hazardous materials. It is intended for members of a hazardous materials response team, teams that are being formed, or for others who may be called upon to respond to a chemical emergency.

The focus of the course is on recognizing and evaluating a hazardous materials incident, organizing the response team, protecting response personnel, identifying and using response resources, implementing basic control measures, decision-making and protecting the public.

Topics to be discussed are: chemical and physical properties of hazardous materials; toxicology; recognition and identification of hazardous materials; direct-reading instruments; standard operating guides, personnel protection and safety; and sources of information.

This program will concentrate on response to hazardous materials emergencies, including transportation-related incidents, at the Technician Level using the criteria established by Florida State Emergency Response Commission. The course will be instructed by Emergency Responders Educators and Consultants (EREC), Inc.
